- All quoted products must be accompanied by documentation verifying their origin, and Chinese-manufactured products will not be accepted.

2. Warranty and Service:

• The selected bidder shall be responsible for providing a one-month warranty covering colorfastness and fabric integrity, including stitching. Any faulty or incorrect items will be promptly replaced following the delivery of the supplies

3. Payment Method:

Payments will be made via cross-cheque only after deducting applicable government taxes.

4. Inclusive Pricing:

 Quoted prices should encompass all costs, including freight charges, associated with the supply and delivery of the requested products.
